

CONSENT, RELEASE, WAIVER, ASSUMPTION OF RISK,  
AND AGREEMENT TO INDEMNIFY

For and in consideration of being permitted to participate in a dove and/or duck hunt with Ten Oaks Hunting, LLC on any of the properties it may manage, lease and/or own, I, the undersigned participant, hereby for myself and my heirs, executors, administrators, and assigns, execute and deliver this Consent, Release, Waiver, Assumption of Risk and Agreement to Indemnify in favor of Ten Oaks Hunting, LLC, its Members, Managers, agents, servants, officers, and employees and Raymond L. Galloway, Jr., Raymond Leslie Galloway, III, and Ryan Lane Galloway, Lessors, their heirs, executors, administrators, and assigns (all referred to herein as Releasees), and voluntarily release, discharge, waive, relinquish, and assume the risk with respect to any and all actions or causes of action against Releasees for personal injury, property damage or wrongful death occurring to me arising as a result of engaging in said dove and/or duck hunting activity, or any activities incidental thereto, wherever or however the same may occur, for whatever period said activities may continue, and whether the same shall arise by the negligence of the Releasees or otherwise.

Further, I agree to indemnify and hold the Releasees harmless from any claims that may be brought by my family members and guests against the Releasees for personal injury, property damage or death sustained by them or by me, or the consequences thereof, including loss of consortium, as a result of their participation as my guest in a dove and/or duck hunt with Ten Oaks Hunting, LLC.

I also agree for myself and my heirs, executors, administrators and assigns that in the event that any claims for personal injury, property damage or wrongful death, or the consequences thereof, including loss of consortium, shall be prosecuted against the Releasees for any act or acts by me or my family members or guests, that I shall indemnify and save the Releasees harmless from any and all said claims or causes of action by whomever or wherever made or presented.

I acknowledge having read the foregoing, that I am fully and completely aware of the potential dangers incidental to dove and/or duck hunting activities, that my participation and that of my family members and guests is purely voluntary, that I have inspected the premises as deemed necessary, and that I am fully aware of the legal consequences attendant to signing/executing this Consent, Release, Waiver, Assumption of Risk, and Agreement to Indemnify. I further declare and represent that no promise, inducement, or agreement not herein expressed has been made to me, and that the terms of this Consent, Release, Waiver, Assumption of Risk and Agreement to Indemnify are contractual and not a mere recital.
