Wednesday hunts	October 7, 2026 through January 31, 2027
Guest fee	\$50 per hunt beginning October 2026 · ONE guest per Member · Members must accompany all guests
Children	One child per Member (NO EXCEPTIONS). No fee for children under 16 for dove hunts.

Opening day: Lunch will be served. Check-in begins 11:30 am. Field hours 12:30 pm to 6:00 pm.

FIELD PROCEDURES

- Members are asked to sign in and out daily when entering and exiting the field, including number of birds. This includes guests. Log is located in the mailbox at the gate.
- Field closes at 6:00 pm each hunt. Members must have hunting license available at all times.

CLUB RULES

- Members and their Guests are required to have a current and valid SC Hunting License.
- Safe hunting is expected from ALL Members and their Guests at ALL times. Any Member and/or Guest acting in an unsafe manner will be required to forfeit hunting privileges and monies paid for the season.
- Anyone hunting at any other time than the field hours will also forfeit their hunting privileges and monies for the season.
- Members and their Guests are responsible for appropriate disposal of his/her trash and debris.
- Members and their Guests are to respect and help prevent any damages to existing crops, buildings, roads, and ditches. In addition, Members and their Guests will assume all risk and responsibility for any accidents or injuries while participating in the Dove Club and will not hold Les Galloway or land owner(s) responsible.
- All Members and their Guests are required to make every effort to retrieve dead or injured birds.
- Membership privilege is only for the harvest of doves and does not include any other fowl or animal. The harvest of any other fowl or animal results in Member and/or Guest forfeiting hunting privileges and all monies paid for the season.
- Members and their Guests are permitted to use dogs as retrievers. Dog owners are required to maintain control of their dogs at all times. Overly aggressive dogs will be asked not to return.
- Consumption of alcoholic beverages and use of illegal substances are not permitted.
- All vehicles should be parked in areas that will not interfere with other hunters, driveways, or paths; preferably along fence.
- Members and their Guests are required to adhere to all SC rules, laws, and regulations concerning hunting in the state of South Carolina. Please refer to WWW.DNR.SC.GOV for limits, times, and dates.
- No shooting toward residential homes or highway; no low bird shots; maintaining adequate distance between hunters is expected.

CLUB RULES

1. Members and their Guests are required to have a current and valid SC Hunting License.
2. Safe hunting is expected from ALL Members and their Guests at ALL times. Any Member and/or Guest acting in an unsafe manner will be required to forfeit hunting privileges and monies paid for the season.
3. Anyone hunting at any other time than the field hours will also forfeit their hunting privileges and monies for the season.
4. Members and their Guests are responsible for appropriate disposal of his/her trash and debris.
5. Members and their Guests are to respect and help prevent any damages to existing crops, buildings, roads, and ditches. In addition, Members and their Guests will assume all risk and responsibility for any accidents or injuries while participating in the Dove Club and will not hold Les Galloway or land owner(s) responsible.
6. All Members and their Guests are required to make every effort to retrieve dead or injured birds.
7. Membership privilege is only for the harvest of doves and does not include any other fowl or animal. The harvest of any other fowl or animal results in Member and/or Guest forfeiting hunting privileges and all monies paid for the season.
8. Members and their Guests are permitted to use dogs as retrievers. Dog owners are required to maintain control of their dogs at all times. Overly aggressive dogs will be asked not to return.
9. Consumption of alcoholic beverages and use of illegal substances are not permitted.
10. All vehicles should be parked in areas that will not interfere with other hunters, driveways, or paths; preferably along fence.
11. Members and their Guests are required to adhere to all SC rules, laws, and regulations concerning hunting in the state of South Carolina. Please refer to WWW.DNR.SC.GOV for limits, times, and dates.
12. No shooting toward residential homes or highway; no low bird shots; maintaining adequate distance between hunters is expected.
